## Absence/Cancellation/Withdrawal Policy

- If Bovine Metropolis Theater cancels a class there is 100% reimbursement of deposit.
- Cancellation by student 14 + days before a scheduled class: Full reimbursement minus a \$25 cancellation fee of the initial deposit.
- Cancellation by student 7-13 days before a scheduled class: Forfeit 50% of initial deposit plus a \$25 cancellation fee OR a credit to be applied toward a future class to be taken within 12 months.
- Cancellation by student 0 - 7 days before a scheduled class: Forfeit 100% of deposit OR a credit to be applied toward another class to be taken within 12 months.
- We are sorry, once class has started there are no refunds of deposits or tuition.
- We are sorry tuition can not be prorated due to student absences.

## Referral Policy

We pay you for referring us! Students who refer other students and it results in them enrolling in a class, will earn a one time \$25 tuition credit. There is no maximum amount of referrals and several referrals could theoretically pay for one whole level of tuition.
